- 2. **Minutes** of the AGM held on 23<sup>rd</sup> September 2013 in Bali Approved.
- 3. **Officers' Reports**: President, Chairman, Secretary (attached)
  Patrick Jourdain welcomes a new Honour Member to IBPA: Yves Aubry, president of the EBL.
- 4. **Appointees' Reports**: Editor, Liaison Officer, Membership Secretary (attached) Panos Gerontopoulos has notified his retirement as Liaison office. The President thans him for his help in creating the agreement with the WBF. The executive will appoint a new Liaison Officer.

#### 5. Treasurer

Accounts for the year ending 31st December 2013 is read out by Per Jannersten. The accounts follow the US system, which makes them hard to interpret. We are running at an annual deficit of around 500\$, but have ample reserves to cover this. The accounts are approved.

Auditor's report for 2013 (Richard Fleet) read out by Per Jannersten – Approved.

Budget: presents a loss, but travel expenses are frequently left unneeded. - Approved

Proposal regarding subscriptions for the year 2015: they can remain unchanged – Approved.
